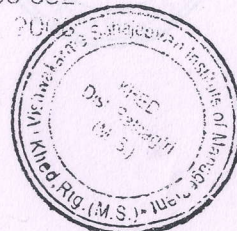

The college has also to fulfill the following affiliation conditions -

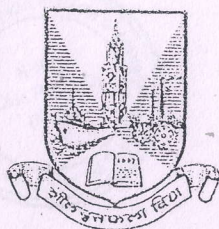
- 1) that the conditions laid down by the University from time to time.

during the academic year and college will have to complete syllabus of all the
subjects during the academic year.
- 3) Admissions should not be linked with donations.
- 4) that they will strictly follow the Ordinance 2802 in respect of preventing the
colleges and Management of Colleges from accepting donation or capitation fees
for admission of students in the Colleges, quoted in the University Circular
No.Aff./Recog./49 of 1987, dated 4th February, 1987 (copy enclosed.)
- 5) that they should follow the norms as prescribed and circulated by the University,
vide No.CONCOL/75 of 1988, dated 3rd March, 1988 (copy enclosed).
- 6) the college shall not admit the students over and above sanctioned intake.
- 7) the college shall appoint the teaching as well as non-teaching faculty as per the
University and U.G.C. norms and also provide infrastructure facilities for the
purpose.
